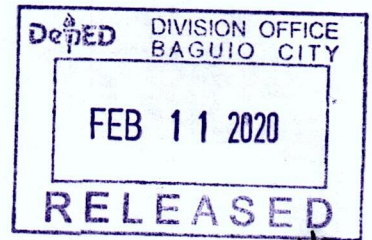

Pursuant to Rule 8, Chapter 6, Sections 49, 50 and 51 of Republic Act (RA) No. 8491 otherwise known as the Flag and Heraldic Code of the Philippines, the Office of the Schools Division Superintendent has released the official seal of the Department of Education Schools Division of Baguio City duly approved by the concerned authorities.
2. The DepEd SDO Baguio City official seal shall be utilized in all official communications and it shall be released to our schools division, districts, schools and other field offices.
3. It may appear on full color, grayscale or in black and white, and in different sizes with the following symbolism and specifications:

Seal Symbolism and Meaning:

Topography of Baguio City:

- Sky, Mountains, Trees, and Panagbenga Sunflowers

Blue Outside Ring:

- Peace, Baguio Color

Shield / Kalasag:

Caring, Child Friendly, and Nurturing Institution

Bag-iw / Moss:

- Where the name of the city was derived.
- Moss which is abundant in the area blanketing the vista of this mountainous city.

Gong:

- IP Education

Rope:

- Unity and Harmonious Partnership with Stakeholders

Laurel Leaves / Wreath:

- Symbolizes the whole development of learners and the significance of education to the community.

Two Stars

- The two stars symbolize Excellence with Harmony and Balance.

- When the Schools Division Office of Baguio City was established.
