

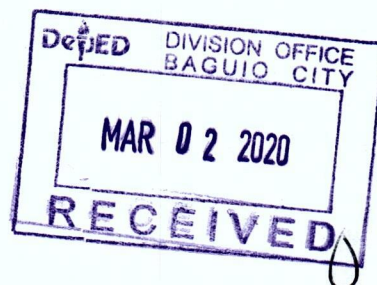

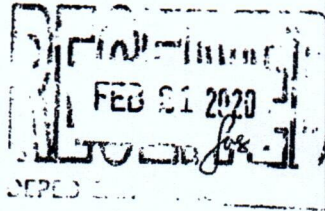

In compliance to DepEd Memorandum No. 15, S. 2020 dated February 4, 2020 re: suspension of all national and regional activities involving learners and teachers requiring travel and congregation of various schools, we postponed our 58th Senior and 46th Junior Regional Camps scheduled on February 6-9 and Feb. 13-16, 2020, respectively, at Kultura Splash Wave Resort, Pugo, La Union.

Hence, it is our pleasure to note that DepEd has already allowed resumption of national, regional and off-campus activities starting February 24, 2020 per DepEd Memo No. 23, S. 2020 or the Third Set of Policy Directives of the DepEd Task Force nCoV.
