RESTATING RM 137.2020 – COMPLIANCE OF PRIVATE SCHOOLS AND STATE/LOCAL UNIVERSITIES AND COLLEGES (SUCS/LUCs) OFFERING BASIC EDUCATION PRIOR TO THE START OF SY 2020 – 2021

To: Office of the Schools Division Superintendent Curriculum Implementation Division School Governance and Operation Division Private School Principals/Administrators All Others Concerned

- 1. Pursuant to Regional Memorandum 137.2020 and RA 7797 stating that schools are allowed to open classes on the first Monday of June but not later than the last day of August, provided that schools observe the following:
 - a. No face-to-face classes will be allowed earlier than August 24, 2020.
 - b. Submission of the following requirements to the Schools Division Office for endorsement to the DepEd Regional Office for review and monitoring purposes.
 - i. School Plan in compliance with minimum health standards consistent with guidelines of the DOH and the IATF. Refer to Division Memorandum 212, s. 2020 at depedpines.com entitled "Minimum Health Protocols in the Office and Schools upon Return to Work" as a guide. Schools may set up own triage, barriers, request for X-Ray, CBC from personnel and other health and safety measures.
 - ii. School Learning Continuity Plan (LCP) adopting the following RM 136, 2020 template: "DepEd is addressing challenges in the basic education through the Learning Continuity Plan (LCP), which will be in effect by the time School Year 2020-2021 opens on August 24, 2020. The LCP is our major response and our commitment in ensuring the health, safety, and well-being of our learners, teachers, and personnel in the time of COVID-19 while finding ways for education to continue amidst the crisis for the upcoming school year." —Sec. L. Briones.
