**SUBJECT :** SUGGESTED OPTIONS FOR PRINTED SELF-LEARNING  
MODULES (SLMs)

**DATE :** JULY 20, 2020

In view of the need to ensure that Self Learning Modules (SLMs) are compliant with the standards set by the Bureau of Learning Resources, there are SLMs which have not been fully quality-assured by the Central Office Conformance Review Teams as of today. There are 612 out of 777 SLMs expected from the 945 MELCs for the first month of School Year 2020-2021 ready for reproduction. This means that SLMs in grade levels and subject areas which have not been fully reviewed cannot be reproduced for use by the learners.


As announced during previous MANCOM Meetings, the Regional Offices (ROs), Schools Division Offices (SDOs) and schools are encouraged to consider the following options for learning resources to be used in implementing printed modular distance learning delivery modality once the school year opens:

- A. Locally developed SLMs; and/or
- B. DepEd Textbooks/Learner's Materials - mapped against the Most Essential Learning Competencies (MELCs) together with Activity Sheets and Weekly Learning Plans.

SLMs and MELCs-Mapped Textbooks/Learner's Materials are available from the ICTS created MS Teams.

Widest dissemination of this OUCI Memorandum is desired.
