WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of meals and snacks for the conduct of **"ISO Training"** with an Approved Budget for the Contract (ABC) of **One Hundred Sixty Two Thousand Five Hundred Pesos only (₱162,500.00)** (Annex A);



WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;




