**ONLINE PROCEDURE**  
(updated as of March 11, 2020)

1. Log on to **[online.prc.gov.ph](http://online.prc.gov.ph)** or **[online1.prc.gov.ph](http://online1.prc.gov.ph)**
2. Read the WEBSITE'S USER GUIDE
3. For **EXISTING ACCOUNT**, click **SIGN-IN**  
For **NEW ACCOUNT**, click **REGISTER**, complete the required
4. Select **EXAMINATION**
5. Select Preferred PRC Regional Office. Click **RESCHEDULE?** if you wish to change the system-generated schedule. **NO SAME-DAY APPOINTMENT POLICY. TRANSACT ONLY AT THE INDICATED APPOINTMENT PLACE** Choose payment option [(**LANDBANK**, **PAYMAYA** and **UCPB** (3-day validation))]
6. Choose payment option (**UCPB OVER-THE-COUNTER PAYMENT** (2-3-day payment validation), **PAYMAYA USING CREDIT CARD OR DEBIT CARD**, **PAYMAYA LOAD WALLET**, or **LANDBANK ONLINE PAYMENT**). For Landbank and PayMaya Load Wallet payment option, you will be re-directed to their website for the processing of payment. If **PAYMENT IS UNSUCCESSFUL** or **CANCELLED**, please email [car@prc.gov.ph](mailto:car@prc.gov.ph)
7. Click **PRINT DOCUMENT** and **PRINTER ICON** to print for Application Form
