### III. Rationale:

The Civil Service Commission (CSC), through the issuance of Memorandum Circular (MC) No. 06, series of 2012, sets the guidelines on the establishment and implementation of the Strategic Performance Management System (SPMS) in all government agencies. The SPMS gives emphasis to the strategic alignment of the agency's thrusts with the day-to-day operation of the units and individual personnel within the organization.

As a learner-centered institution, the Department of Education (DepEd) is committed to continuously improve itself to better serve the Filipino learners and the community. The adoption of the SPMS in DepEd strengthens the culture of performance and accountability in the agency, with the DepEd's mandate, vision and mission at its core.

The SDO- Baguio through the School Governance and Operations Division has conducted trainings to capacitate RPMS trainers who shall continuously provide coaching and mentoring to teachers and non-teaching personnel. To date there are 36 female and 31 male School Heads, 157 female and 51 male Master Teachers, 28 female and 28 Head teachers and who are tapped as RPMS trainers in the division. As an RPMS trainer, they are likewise mandated as coach and mentor and observers during classroom observation. Their roles and functions were presented in a division orientation prior to their designation as RPMS trainer. However, there are some of these RPMS observers who have not undergone capability building. Hence, they could not function well as observers in the classroom observation.

This training program proposal anchors on the performance management system of DepEd with focus on capacitating raters/observers as the agency is mandated to ensure that the employees shall improve the management of their system through the RPMS.
