RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT – SMALL VALUE PROCUREMENT TO PANGHOI ENTERPRISES

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of office supplies for LRMDS use with an Approved Budget for the Contract (ABC) of One Hundred Twenty Four Thousand Eight Hundred Twenty Two Pesos only (\$\mathbf{P}124,822.00) (Annex A);
