 - d. *For BERF only*: Certification that the proponent is regular / permanent teaching or non-teaching personnel of the Department of Education and have no pending cases attested by Administrative Officer V and Attorney III. (Enclosure 3)
 - e. Copy of the evaluation and approval from SDRC
4. The absence of one of the required documents or incomplete research proposal will be disapproved without further evaluation.
5. Original signed documents shall be submitted later.
6. All proponents of approved proposals will be notified for coaching and orientation.
