
1. Pursuant to DepEd Order No. 10 s. 2016 entitled, "Policy and Guidelines for the Comprehensive Water, Sanitation and Hygiene in Schools (WinS)" and Division Memorandum No. 98, s. 2021 entitled, "Participation of all Public School in LGU Activities in Response to the CoViD-19 Outbreak", the Office of the Schools Governance and Operations Division reiterates the submission of the above mentioned reports. Deadline of submission is on **April 23, 2021 12:00nn.**

2. As of April 20, 2021, only 64.17% complied with the quarantine area assessment tool and only 67.16 submitted their WinS Report. Enclosure No. 1 of this memorandum is the submission status of both elementary and secondary schools.

3. The acceptance of online updating of WinS Online Monitoring System already ended, thus, concerned school heads are enjoined to submit a hard copy of their WinS report to the Office of Schools Health and Nutrition Section. Additionally, the quarantine area assessment tool is submitted through google form.
