The Department of Education – Cordillera Administrative Region (DepEd-CAR) through its Regional Disposal and Appraisal Committee (RDAC) will conduct public bidding through sealed bids on April 29, 2021 at 1:00 PM at SNC Hall DepEp-CAR Regional Office, Wangal, La Trinidad, Benguet, for the sale of the following unserviceable properties on an "As-Is-Where-Is, basis as indicated below:

Bidding mechanics:

- The public bidding will be conducted in accordance with COA Circular No. 89-296 dated January 29, 1989;
- 2. Upon payment of of a non-refundable Bid Fee of Five Hundred Pesos (PhP 500.00) to the DepEd-CAR Cash Section, interested bidders may get the bid documents from the RDAC secretariat on April 26-29, 2021 during office hours at the Asset Management Section, DepEd-CAR Regional Office, Wangal, La Trinidad, Benguet. It can also be downloaded through the PS Website.
- All bid proposals shall use the bid form obtained from the RDAC. The bid form shall be accomplished in two (2) original copies with signature in each and every page and shall be submitted in a sealed envelope properly addressed to:

- 4. All bids must be accompanied by Invitation to Bid with signature in each and every page as a proof of understanding the mechanics of public bidding and bid bond/s in the form of cash, manager's check or cashier's check acquired from a reputable bank with an amount equivalent to at least 10% of the floor price for the lot to be bid. All checks should be payable to DepEd-CAR.
- 5. Qualification of bidders: all individuals, including DepEd-CAR employees, partnerships and/or corporations are qualified to participate in the public auction subject to the submission of qualification documents, as may be required by the RDAC. For this bidding, the latest and valid Mayor's Permit, in the case of business entities, shall be required from participating bidders.
- All interested bidders may conduct ocular inspection of the unserviceable properties on April 26 - 29, 2021 at DepED-CAR Regional Office, Wangal, La Trinidad, Benguet.
- 7. Bid proposals shall be submitted not later than April 29, 2021 until 1:00 PM only through the RDAC at the Asset Management Section, DepED-CAR Regional Office, Wangal, La Trinidad, Benguet. The public bidding shall be conducted on a lot and "As is, Where is" bases subject to other terms and conditions which RDAC may impose. Late bids shall not be accepted. The opening of the bids will be on April 29, 2021, immediately after the deadline at the SNC Hall.
- 8. The envelope containing the bid form and other requirements should be sealed and signed by the bidder and properly labeled containing the name of the bidder and the lot to be bid. The bid tenders that are not in the prescribed form or format (e.g. unsigned bids, etc.) and/or those not accompanied by the signed Invitation to Bid and/or bid bonds at the time the of opening of bids shall be considered defective bids which automatically disqualify the respective bidder.
- 9. A bidder may be allowed to withdraw a bid tender before the time of opening of bids. The bid/s shall be returned unopened. Changes shall not be allowed on the bid forms after the deadline for the submission of bids.
- 10. Sealed bids shall be submitted to the RDAC, Asset Management Section, DepEd-CAR Regional Office, Wangal, La Trinidad, Benguet. All bids will be opened in the presence of bidders or their duly designated representative/s who choose to attend and COA representative.


- 11. The winning bidder shall be the proposal with the highest offered price which shall not be lower than the floor price. The declaration of the winning bidder shall immediately follow. The winning bidder shall pay the bid bond to the DepEd-CAR Cashier Section afterwards and shall submit a photocopy of the Official Receipt (OR) to the RDAC secretariat before issuance of the Notice of Award. Bid bond of non-winning bidder/s shall be returned outright after the declaration of the winning bidder.
- 12. Should there be a tie in the highest offered price, the concerned bidders shall participate in a "toss coin" to break the tie.
- 13. The winning bidder's bond shall automatically be considered as a partial payment and the balance shall be paid in full to the DepEd-CAR Cashier Section in the form of cash, manager's check or cashier's check acquired from a reputable bank within five (5) working days from the receipt of the Notice of Award.
- 14. In case of failure of payment of the bid price within the required period, the award shall be cancelled and the bid bond shall be forfeited. The bidder shall also be blacklisted and shall not be allowed to participate in future biddings for a period of one (1) year from the date of award. The subject items for disposal shall be awarded to the next highest bidder.
- 15. The highest winning bidder shall be responsible for the expenses incidental to the cost of hauling the items subject for disposal. The awardee has five (5) working days from the receipt of the Notice of Award to clear the area where the items are located and during office hours from 8:00AM to 5:00PM. In case the winning bidder fails to complete the pick-up/hauling of the property within prescribed period, the award shall be revoked/cancelled and the bid bond will be forfeited. The bidder shall also be blacklisted and shall not be allowed to participate in future biddings for a period of one (1) year from the date of award. The next highest bidder shall be awarded the bid, so forth and so on.
- 16. Failure of bidding shall be declared if all prospective bidders are declared ineligible; no bids are received; all bids fail to comply with the bid requirements; all bids are below the floor price; the winning bidder refuses to accept the award or the winning bidder fails to make the payment on time.
