RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the procurement of printer unit for the conduct of "JDVP Implementation Reports" with an Approved Budget for the Contract (ABC) of *Eleven Thousand Two Hundred Forty Pesos only (₱11,240.00)* (Annex A);
