



RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT – SMALL VALUE PROCUREMENT TO JSCG ENTERPRISES, OPC

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of cell cards as communication allowance for the conduct of “Regional Home Based Online Assessment Test” with an Approved Budget for the Contract (ABC) of **Sixty Three Thousand Five Hundred Twenty Five Pesos and 32/100 only (₱63,525.32)** (Annex A);

WHEREAS on January 7, 2021, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/distributors signified their intent to participate by submitting their respective quotations/proposals, to wit:

WHEREAS the proposal of **JSCG ENTERPRISES, OPC** is found to be the most compliant with the PR, and its price quotation amounting to **Sixty One Thousand Seven Hundred Ten Pesos only (₱61,710.00)** is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated responsive bid;

WHEREAS Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative.

RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the procurement of cell cards as communication allowance for the conduct of “**Regional Home Based Online Assessment Test**” with an Approved Budget for the Contract (ABC) of **Sixty Three Thousand Five Hundred Twenty Five Pesos and 30/100 only (P63,525.30)** (Annex A);

WHEREAS the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;


WHEREAS pursuant to Section 48 of the afore-cited Rule, the Department of Education – Division of Baguio City (DO) may resort to the alternative method of procurement – Small Value Procurement to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex “H” of the IRR and does not fall under shopping in Section 52 of this IRR;

NOW THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to resort to the alternative method of procurement – **Small Value Procurement** for the procurement of cell cards as communication allowance for the conduct of “**Regional Home Based Online Assessment Test**”;
