RECOMMENDING THE AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO RIANELLA PRINTING PRESS FOR THE POCUREMENT OF REPRODUCTION OF SELF LEARNING MODULE FOR KINDER TO GRADE 3 IN ALL LEARNING AREAS

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of **Reproduction Of Self Learning Module For Kinder to Grade 3 in all learning areas** with an Approved Budget for the Contract (ABC) of **Three Hundred Ninety-One Thousand Five Hundred Forty Eight Pesos Only (Php391,548.00)** (Annex A);

WHEREAS on February 24, 2021, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following supplies/distributors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:

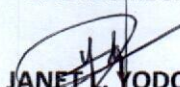

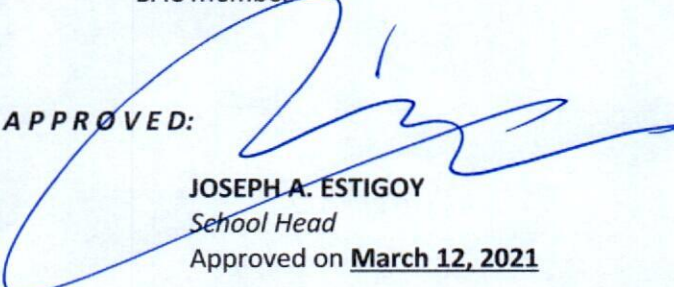
