FULL IMPLEMENTATION OF PRC'S ONLINE SERVICES AND THE EXTENSION OF THE VALIDITY OF PROFESSIONAL IDENTIFICATION CARD OF ALL COVERED PROFESSIONALS DURING COMMUNITY QUARANTINE PERIOD

To ensure the protection health and safety of the professionals, aspiring professionals and personnel, effective March 22, 2021, the Professional Regulation Commission Cordillera Administrative Region (PRC-CAR) shall strictly implement the policy on **NO APPOINTMENT, NO TRANSACTION, NO ENTRY** for the following services:


- Renewal of Professional Identification Card (PIC)
- Certification of Passing, Board Rating, Good Standing
- Authentication of Certification of Passing, Rating, Good Standing
- Application for Examination
- Registration of License

EXCEPT for hereunder WALK-IN services:

- Petition for Change of Name due to Marriage and Correction of Entries
- Stateboard Verification
- Claiming of Certificate of Registration


Transactions with PREVIOUS/LAPSED appointment date shall be processed between 2:00 PM and 5:00 PM. For queries and concerns, email car@prc.gov.ph, or call 0927-788-0145 (renewal and initial registration), 0949-475-3219 (CPD and virtual oath-taking), 0910-963-8887 (application and exam), 0938-616-1546 (resetting of password or retrieval of user email account) and 0919-573-5600 (general queries).

Further, per PRC Resolution No. 1234 (s 2020) and Memorandum Circular No. 03 (s 2020), the extension of the validity of the PICs of all concerned professionals shall be enforced for the whole duration of any community quarantine imposed by the national and local government. It is the intention of the Commission, with the support of the concerned Professional Regulatory Boards, to give effect on the extension of the validity of PICs until any restrictions from the community quarantine is lifted to ensure the protection, health and safety of the concerned professionals including its personnel.
