



RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT – SMALL VALUE PROCUREMENT TO DAD’S PLACE TRANSIENT HOUSE AND RESTAURANT

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of meals and snacks for the Division Selection Committee Meetings and Assessment for the Registry of Qualified Teacher Applicants with an Approved Budget for the Contract (ABC) of **Sixty Three Thousand Pesos only (₱63,000.00)** (Annex A);

NOW THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to resort to the alternative method of procurement – **Small Value Procurement** for the procurement of meals and snacks for the Division Selection Committee Meetings and Assessment for the Registry of Qualified Teacher Applicants;


