

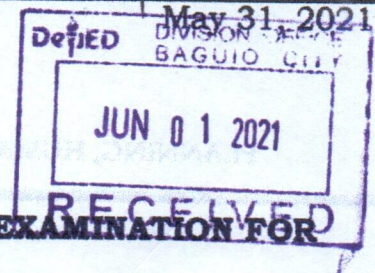

**SURVEY ON THE 2021 NATIONAL QUALIFYING EXAMINATION FOR SCHOOL HEADS (NQESH)**

1. This is in reference to DM-PHROD-2021-0081 "Conduct of the National Qualifying Examination for School Heads (NQESH) 2021". This office through the Quality Assurance Division (QAD) would like to conduct a survey as to the number of qualified takers for the 2021 NQESH. The purpose of the survey is to make necessary preparations or contingency plan as to the test administration considering that the test will be on a face-to-face modality.
2. For the meantime, the 2018 NQESH Qualification of Test Takers will be our basis for this survey, to wit:
  - One year as Head Teacher, or
  - Two years as Teacher-In-Charge, or
  - Two years as Master Teacher, or
  - Five years as Teacher III or SPED Teacher, or
  - Five years as incumbent public school teacher who has five years of managerial and supervisory experience in a DepEd-recognized private institution or Commission on Higher Education (CHED) recognized higher education institution.



**SUBJECT:** *Conduct of the National Qualifying Examination for School Head (NQESH) 2021*

**DATE:** 15 February 2021

With reference to Department Order No. 24 s. 2020, the National Adoption and Implementation of the Philippine Professional Standards for School Heads (PPSSH), the Bureau of Human Resource and Organizational Development has commenced its preparatory work to align the competency assessment and examination with the standards set by the PPSSH.

As DepEd moves towards competency-based HR, the NQESH will remain its primary mechanism to safeguard and gauge the competency and quality of the aspiring school leaders in DepEd schools.

In view thereof, please be informed that the NQESH shall resume this year (FY 2021). The schedule and other details related to it shall be announced in the second quarter of 2021.
