WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of meals and snacks for the conduct of "2021 Pammadayaw" with an Approved Budget for the Contract (ABC) of **Eighty Thousand Pesos only (₱80,000.00)** (Annex A);

WHEREAS on July 12, 2021, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, to wit:







WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;




