**SUBJECT:** Invitation to the Third National Summit on the Rights of the Child in Education on November 25-26, 2021 via Zoom and Requests for a Brief Written Message for the Souvenir Program and Recorded Recitation of *Panatang Makabata*

**DATE:** November 8, 2021

The Department of Education, through the Child Rights in Education Desk (CREDe) under the Office of the Undersecretary for Legal Affairs (OULA), would like to invite you to the **Third National Summit on the Rights of the Child in Education on November 25 to 26, 2021, every 1:00 p.m. to 4:00 p.m** via Zoom online platform. This event will serve as the culminating activity of DepEd in celebration of the National Children's Month this November, pursuant to DepEd Memorandum No. 75, s. 2021. On the week prior to the Summit, on November 19, 2021, there will be a Pre-Summit Conference for Children and Learners to help them prepare for participation with adults in the Summit.

With the theme, "*Batang May K: Karapatan ng Bata sa Edukasyon, Katuwang ang Lahat sa Pagsulong*", the Third Summit aims to reinforce the continuing commitment of the DepEd and other stakeholders in upholding children's rights in education in normal times and during the COVID-19 pandemic. It aims to build on the gains of the Second National Summit on the Rights of the Child in Education held last November 2020, and to discuss the rights-based education (RBE) framework of DepEd and the newly created Child Rights in Education Desk (CREDe) under the Office of the Undersecretary for Legal Affairs pursuant to DepEd Order No. 3, s. 2021, entitled "Creation of the Child Protection Unit and Child Rights in Education Desk." The Child Protection Unit under the Office of the Undersecretary for Field Operations will also be introduced.

The Third National Summit seeks to facilitate discussions and elicit recommendations on upholding the rights of the child TO accessible and quality basic education and the rights of the

child IN basic education including, but not limited to, the right to participation, protection, rest and play, health and non-discrimination under the RBE framework in normal times and during the COVID-19 pandemic through a whole-of-school, whole-of-DepEd, whole-of-government, and whole-of-society approach. It is also a venue to ensure the participation of children in shaping policies and actions pertaining to RBE. The Summit will be a ground-breaking and seminal opportunity to discuss the RBE framework of DepEd in relation to the initiatives and efforts of the DepEd on child rights including the work of CREDe, and the points for collaboration among stakeholders of child rights TO and IN education.

The Third Summit will be conducted virtually within the Zoom platform with different officials and personnel from the DepEd national and local offices as well as public schools, and representatives from private schools, national government agencies, LGUs, civil society, international organizations, the academe, business community, and the media. More importantly, learners themselves and their parents, guardians, and caregivers will also participate. We will also stream the Third Summit live to thousands of viewers at the DepEd Philippines Facebook Page.

We sincerely hope that you will be able to join us in the upcoming Summit, in affirmation of your commitment to RBE, and in solidarity with the DepEd family and the stakeholders of children's rights and RBE. Relatedly, for the Souvenir Program of the Summit, we would like to request for a **short written message of about 100 words**, anchored on the Third Summit's theme in support of the rights of the child in education and implementation of RBE. Kindly send the message in PDF and MS Word with your **high-resolution headshot photograph**.

We would also like to request for a recorded recitation of the attached *Panatang Makabata* from the Council for the Welfare of Children, which is collectively recited during flag ceremonies in government offices and other activities on child rights during the National Children's Month every November. The recording will be used for a video montage of DepEd officials, headed by the Secretary, and other stakeholders reciting the *Panatang Makabata*. For those who submitted a video recording last year, your video recording was used in a video montage which was shown in the previous Summit. Please inform us whether we can still use that previously submitted recording or you would like to submit a new recording.

We request that the pre-recorded recitation of *Panatang Makabata* as well as the brief Souvenir Program message and headshot photograph be sent to us by **November 16, 2021**. For the requested recordings, please use a computer webcam or an external webcam. For cellphone recording, please ensure that the file size is set at least 1920 x 1080P resolution (MP4 or MOV), as shown in the phone settings, with a frame rate of preferably 30 to 60 FPS, and MP3 format for audio. Kindly record with the cellphone set horizontally (or in landscape orientation) and ensure that your whole face is visible in the video, with the cellphone set at the right level.

A copy of the Indicative Program and the Summit Concept Note are attached for your reference. Further details about the Summit will subsequently be provided once finalized. **Third National Summit on the Rights of the Child in Education  
and Pre-Summit Conference of Children**

**Concept Note**

**I. Background and Rationale**

Children and their rights are at the center of basic education.

The Department of Education (DepEd), through the Office of the Undersecretary for Legal Affairs (OULA), launched the First National Summit on the Rights of the Child in Education in November 2019, on the milestone occasion of the 30<sup>th</sup> anniversary of the United Nations Convention on the Rights of the Child and in celebration of the National Children’s Month. The DepEd, fully committed to the rights of the child and undeterred by the COVID-19 pandemic, mounted the Second National Summit on the Rights of the Child in Education in November 2020, albeit held on a virtual platform. In both Summits, rights-based education (RBE) and strengthening the implementation of the rights of the child in education were central topics. As emphasized, RBE pertains to the range of rights of children in education, not only the right to education in terms of access and quality, but also the right to participation, right to protection, right to non-discrimination, right to health, and right to play, among others.

This November 2021, the DepEd, through OULA, will hold the **Third National Summit on the Rights of the Child in Education on November 25-26, 2021**. The Third National Summit is not only a continuation of the first two summits, but also a breakthrough occasion. Building on the gains of the first two summits, the DepEd, in recognition of its duty to uphold and continuously strengthen the rights of the child in basic education, issued **DepEd Order (D.O.) No. 3, s, 2021, entitled “Creation of the Child Protection Unit and the Child Rights in Education Desk in the Department of Education”** on January 15, 2021. The Third National Summit will provide a ground-breaking and seminal opportunity to introduce the rights-based education framework of DepEd, the Child Rights in Education Desk (CREDe, pronounced as “creed”) and its work, initiatives and efforts of the DepEd on child rights, distance and limited face-to-face education during the COVID-19 pandemic, and opportunities and points for collaboration among stakeholders of child rights in education.

CREDe was created to uphold the holistic development of the child, in pursuit of the vision of the DepEd of “child-centered and child-caring basic education schools, learning centers, and offices, which respect, protect, promote, and fulfill the dignity and rights of the child in basic education so they may lead productive and happy lives as they participate in nation-building.” The CREDe, using a legal and child rights lens, is mandated to act as the lead unit of DepEd to flesh out and articulate standards and meanings of child rights in basic education, as well as advocate, increase knowledge, and build capacity in relation to the rights of the child in basic education, with a view to anchoring and integrating child rights in the mandate and work of the DepEd.

As with the first two Summits in 2019 and 2020, the Third National Summit will reflect a whole-of-DepEd, whole-of-government and whole-of-society approach in upholding the rights of the child in education. Thus, participants in the Third National Summit will include officials and representatives from all governance levels of DepEd nationwide, public and private schools, the three branches of government, local government units, NGOs and international organizations, the academe, professional organizations, business, media, parents, and the children and learners themselves. However, as the rights-based

framework of DepEd employs a whole-of-school approach, there will be emphasis on, and additional speakers and representatives from the school and its local community.

Consistent with the first two Summits, the Third National Summit will highlight the right of children to participation, to have their views heard and taken seriously on matters affecting them, with consideration of their evolving capacities and maturity as children. Significantly, speakers and participants will include children-learners with diverse backgrounds. To elicit their views and suggestions on the Summit design and prepare them for their participation in the Summit, there will be a **Pre-Summit Conference of Children on November 17, 2021**.

This Third Summit will be the culmination of DepEd's celebration of the 2021 National Children's Month. It is an affirmation and reinforcement of the full commitment of the DepEd to uphold the rights of the child in education in normal times and during the COVID-19 pandemic.

## II. Objectives

### Third National Summit on the Rights of the Child in Education

- Build on the gains of the Second National Summit on the Rights of the Child in Education held last November 2020;
- Reinforce the continuing commitment of the Philippine government, including the DepEd and its newly created Child Rights in Education Desk, and other stakeholders in upholding children's rights in education in normal times and during the COVID-19 pandemic;
- Introduce the rights-based education (RBE) framework of DepEd and the Child Rights in Education Desk (CREDe);
- Facilitate discussions and elicit recommendations on upholding RBE in normal times and during the COVID-19 pandemic through a whole-of-school, whole-of-DepEd, whole-of-government, and whole-of-society approach; and
- Ensure the participation of children in shaping policies and actions pertaining to RBE in normal times and during the COVID-19 pandemic.

### Pre-Summit Conference with Children

- Orient children participants on the objectives of the Summit and the Pre-Summit Conference with Children;
- Educate children participants on the rights-based education (RBE) framework of DepEd and their right to participation in their education;
- Orient children participants on online safeguarding;
- Elicit comments and recommendations from children participants on the following:
  - The topics to be discussed during the plenary and breakout sessions of the Summit;
  - The conduct of children and adult participants of the Summit;
  - Means of ensuring optimum participation and engagement of children participants during the Summit;
- Elect children representatives to report the output of the Pre-Summit Conference during the Summit.

## III. Theme

The theme of the Summit is *"Batang May K: Karapatan ng Bata sa Edukasyon, Katuwang ang Lahat sa Pagsulong!"* This theme emphasizes the commitment of DepEd, through the help of CREDe, to respect, protect, promote and fulfill the rights of every child in the context of basic education in normal times and during the COVID-19 pandemic. It is stated from the point of view of both the child as the rights-holder

and the adult as the duty-bearer. It calls on everyone to work together, including children themselves, to uphold the rights of the child in education with a whole-of-school, whole-of-DepEd, whole-of-government and whole-of-society approach.
