



RECOMMENDING THE AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO ML CONSUMER GOODS TRADING FOR THE PROCUREMENT OF OFFICE SUPPLIES FOR THE REPRODUCTION OF SLMS OF ELPIDIO QUIRINO ELEMENTARY SCHOOL

WHEREAS Elpidio R. Quirino Elementary School prepared the Purchase Request (PR) for the payment of **SUPPLIES FOR THE REPRODUCTION OF SLMS QUARTER MODULES** with an Approved Budget for the Contract (ABC) of FIFTY SIX THOUSAND ONE HUNDRED FORTY ONE PESOS ONLY (56,141.10) (Annex A);

WHEREAS on NOVEMBER 4, 2021 the Elpidio R. Quirino Elementary School– Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/distributors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:

Cokins Everywear General Merchandise	Php 54,750.00
Panghoi Enterprises	Php 56,035.00

WHEREAS per evaluation, below are non-compliant with the specifications set forth in the TOR:

Supplier/Distributors	Non-Compliance
Cokins Everywear General Merchandise	Quote with in ABC but with quotation is higher than the lowest
Panghoi Enterprises	Quote with in ABC but with the highest bid

WHEREAS the proposal of **ML CONSUMER GOODS TRADING** found to be the most compliant with the PR, and its price quotation amounting to FIFTY-FOUR THOUSAND SIX HUNDRED FIFTEEN PESOS ONLY (Php 54,615.00) calculated responsive bid;

WHEREAS Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative.

NOW THEREFORE, for and in consideration of the foregoing, **We**, the Members of the Bids and Awards Committee, hereby **RECOMMEND** to the School Head the **AWARD OF CONTRACT** via Negotiated Procurement– Small Value Procurement to **ML CONSUMER GOODS AND TRADING** for the payment of **office supplies** in the amount of FIFTY-FOUR THOUSAND SIX HUNDRED FIFTEEN PESOS ONLY (Php 54,615.00) inclusive of appropriate taxes and fees.


