RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the procurement of plaque for the conduct of **“Recognition Program for 2021 Service Awardees”** with an Approved Budget for the Contract (ABC) of **Sixty Four Thousand Five Hundred Pesos only (₱64,500.00)** (Annex A);

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;


