**REITERATION OF UPDATING THE CPP SCHOOL PROFILE IN THE
DEPED – CAR LEGAL SERVICES INFORMATION SYSTEM (LSIS) 3.0**

To: Public Schools District Supervisors
Public School Heads
Private Schools Heads/Administrators

School CPP Coordinators
School Child Protection Committees
School ICT Coordinators, and
All Others Concerned

1. Since 2016, the Legal Services and Information System (LSIS) had been adopted by DepEd – CAR; and all elementary and secondary schools within the Region was mandated to use the said system in accomplishing CPP documentary requirements pursuant to DepEd Order No. 40, s. 2012 (DO No. 40), otherwise known as the *DepEd Child Protection Policy*;
2. The latest version of LSIS was made available late last year and all of the schools were enjoined to update their CPP School Profile for the School Year 2021-2022;
3. To date, however, there are still **7 public schools** and **84 private schools** which did not update their CPP school profiles (**See Enclosure 1**);
4. Furthermore, out of the 80 schools that already complied, **13 public schools** and **7 private schools** failed to update the *Child Protection Committee* and *Availability of Policy* portions of their CPP school profiles (**See Enclosure 2**);
5. Likewise, there are schools that did not follow the composition of their Child Protection committees. DO No. 40 provides, thus:

“A. The CPC **shall** be composed of the following:

1. School Head/Administrator – Chairperson
2. Guidance Counselor/Teacher – Vice Chairperson

3. Representative of the Teachers as designated by the Faculty Club
 4. Representative of the Parents as designated by the Parents-Teachers Association
 5. Representative of pupils, students and learners as designated by the Supreme Student Council
 6. Representative from the Community as designated by the Punong Barangay, preferably a members of the Barangay Council for the Protection of Children (BCPC).” (emphasis ours)
6. All schools included in the lists attached hereto as Enclosures 1 and 2, are mandated to either update their CPP school profiles, update their CPC and/or availability of their policies, and/or follow the composition of their CPCs pursuant to DO No. 40;
