WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of automatic thermo scanner with alcohol dispenser and stand for SDO Baguio City with an Approved Budget for the Contract (ABC) of Ten Thousand Four Hundred Pesos only (\$\mathbf{P}10,400.00) (Annex A);

WHEREAS on November 9, 2021, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, to wit:
