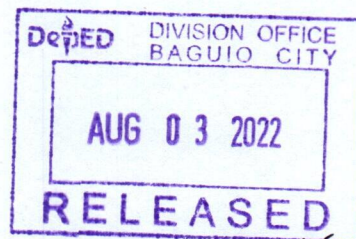

1. Anent to Memorandum OUF-2022-0351 dated 14 July 2022, additional Maintenance and Other Operating Expenses (MOOE) funds will be released/downloaded to your respective schools for the implementation of in-person classes and compliance with minimum health requirements.
2. The use of the additional MOOE shall be consistent with DepEd Memo No. 039, s. 2020, DepEd Order No. 008, s. 2019, DepEd Order No. 014, s. 2020, DepEd Order No. 015, s. 2020, and DepEd Order No. 034, s. 2022.
3. Relative hereto, School Heads are advised to conduct Early Procurement Activities (EPA) short of payment, subject to existing budgeting, accounting, auditing and procurement rules and regulations under RA 9184.
4. Moreover schools are required to submit their respective Work and Financial Plan (WFP), Project Management and Procurement Plan (PPMP), Annual Procurement Plan (APP), and School Operating Budget (SOB) for obligation and cash advance purposes.
5. Enclosed is the schedule of budget allocation for Elementary and Secondary Schools, for reference and guidance.
6. Immediate and wide dissemination of and strict compliance with this Memorandum is desired.
