**WHEREAS** the Department of Education prepared the Purchase Request (PR) for the procurement of **Computer components for upgrade and repair of Division office laptop and desktop computers** an Approved Budget for the Contract (ABC) of **Ninety Thousand Seven Hundred Twenty Pesos Only (₱ 136,800.00)** (Annex A);

**WHEREAS** on June 9, 2022, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:



**WHEREAS** the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;


