





**WHEREAS** the Department of Education prepared the Purchase Request (PR) for the procurement of meals and snacks for the preparation of bridging materials for MTB-MLE Q1 to Q4 – Translation of all MTB-MLE SLMs to Filipino with an Approved Budget for the Contract (ABC) of **Seventy Two Thousand Pesos only (₱72,000.00)** (Annex A);

**WHEREAS** on June 27, 2022, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, *to wit:*




**WHEREAS** the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;




