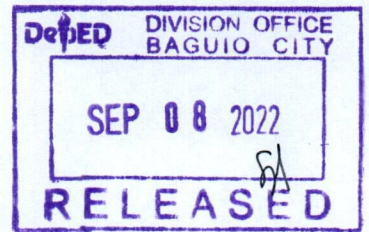

Pursuant to DepEd Order No. 34 s. 2017 "Guidelines on the formation of Consultative and Advisory Bodies on Indigenous Peoples Education (IPEd) and DO 62, s. 2011 entitled "Adopting the National Indigenous Peoples Education (IPEd) Policy Framework" the SDO-Baguio City through the Curriculum Implementation Division (CID) will organize a Consultative and Advisory Body on Indigenous Peoples Education (IPEd) on September 10, 2022, 9:00 AM onwards at the Ecolodge Hotel, Baguio City.
