**WHEREAS** the Department of Education prepared the Purchase Request (PR) for the procurement of shuttle services for the conduct of **“SDO Team Building Activity”** on June 16-17,2022 use with an Approved Budget for the Contract (ABC) of **Eighty Four Thousand Nine Hundred Sixty only (₱84,960.00)** (Annex A);

**WHEREAS** on May 27, 2022, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:

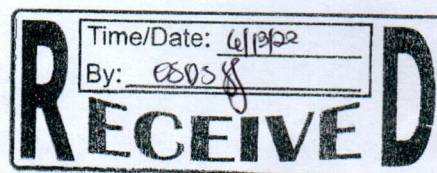
