**FINALIZATION OF THE DEVELOPMENT OF CONTEXTUALIZE AND INTEGRATIVE LEARNING ACTIVITY SHEETS (LAS) AND ASSESSMENT TOOLS IN THE SIX LEARNING STRANDS OF THE ALTERNATIVE LEARNING SYSTEM**

1. Republic Act (RA) 10533 – the Enhanced Basic Education Act of 2013 provides that education should adhere to the standards and principles in developing enhanced basic education curriculum by being contextualized and global as well as by being culture-sensitive. The curriculum should also be flexible enough to enable and allow schools to contextualize and enhance the same based on the respective educational and social contexts. This office through the curriculum Implementation Division – Alternative Learning System releases this memorandum on the conduct of finalization of the development of contextualize and integrative learning activity sheets and assessment tools in the six learning strands of the Alternative Learning System on January 25-27, 2023, at The Orchard Hotel Baguio, Legarda Rd., Baguio City.
2. The activity aims to:
  - a. finalize the development of contextualized, integrative, and gender-responsive learning materials in the six learning strands of the ALS; and
  - b. ensure alignment, coherence, continuity, and consistency of the teacher-made learning materials with the new and K to 12 aligned learning competencies.
3. Participants in the activity are the learning area supervisors (EPSs), ALS teachers, Education Program Specialist II for ALS (EPSA), Division ALS Focal Person, and three personnel from the LRM (EPS, layout artist and illustrator).
4. Expenses relative to the PPA process shall be charged to the 2022 Program Support Fund with the usual accounting and auditing rules and regulations.
