



**WHEREAS** the Department of Education prepared the Purchase Request (PR) for the procurement of **Meals for the SDO Year-end Updates and Thanksgiving Program** with an Approved Budget for the Contract (ABC) of **Seventy Eight Thousand Pesos Only (₱78,000.00)** (Annex A);

**WHEREAS** on December 2, 2022, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:
