WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of **Transportation during the Real Talk (Relax and Learn Team Building Activity for Leader with "K"** with an Approved Budget for the Contract (ABC) **Sixty Four Thousand Pesos Only (₱64,000.00)** (Annex A);

WHEREAS on October 18, 2022, the DepEd – Bids and Awards Committee (BAC) posted/published the Request for Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, to wit:

WHEREAS the proposal of **RUML TRANSPORT** is found to be the most compliant with the PR, and its price quotation amounting to **Sixty Four Thousand Pesos Only (₱64,000.00)** is the most economical and advantageous to the Government, thereby the same as the lowest calculated responsive bid;

WHEREAS Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative.

**NOW THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to resort to the alternative method of procurement – **Small Value Procurement** for the procurement of Transportation during the conduct of **“REAL TALK (Relax and Learn Team Building Activity for Leader with “K””**;


