 - e. Promote mental health of male and female developers, evaluators and personnel in a changed scenery, relaxing and refreshing environment while doing a challenging/difficult task .



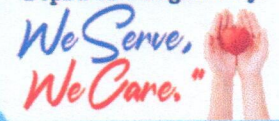
