WHEREAS pursuant to Section 48 of the afore-cited Rule, the Department of Education – Division of Baguió City (DO) may resort to the alternative method of procurement – **Small Value Procurement** to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and does not fall under shopping in Section 52 of this IRR;


