The competition, dubbed as ClusteRICE, shall be conducted on a per cluster basis instead of the usual per region as conducted in the past. The five (5) Clusters are as follows:

3. Northern Luzon (for Region I, II, III and CAR);
4. Visayas (for Region VI, VII and VIII); and


