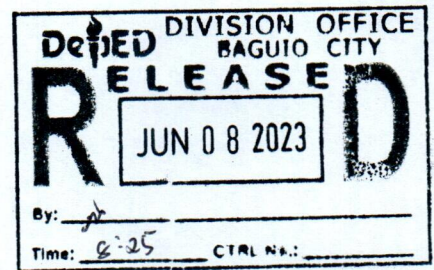

1. Pursuant to DepEd Order No. 62, s. 2011 entitled "Adopting the National Indigenous Peoples Education (IPEd) Policy Framework" the SOD-Baguio City through the Curriculum Implementation Division (CID) will be conducting the Finalization and Printing of SDO- Baguio City Resource Book and other IPEd Advocacy Learning Materials (VO) on June 10-11, 2023 9:00 AM onwards at H100, Ecolodge Hotel, Magsaysay Ave., Baguio City.
2. The objectives of this activity are as follows:
 - a. ensure that the finalized gender-responsive Learning Resources (LRs) are based on the review and revision programs, curriculum, social content guidelines and other references that are free from gender biases and stereotypes, and use gender-fair and inclusive language, positive images, and messages; and
 - b. facilitate the printing of finalized GAD responsive and contextualized learning materials (SDO- Baguio Resource Book and Advocacy Materials) prepared by the developers.
3. Enclosure 1 is the list of participants who are also expected to strictly comply with protocols on social distancing and implement precautionary measures consistent with the IATF health protocols, DOH protection protocols, local quarantine rules and all other relevant protocols outlined in DepEd and DepEd Task Force COVID-19 issuance.
4. Participants are expected to bring extension wire, portable internet connection, laptop/gadget, output per ICC (soft and hard copy) during the evaluation of Resource Book and other IPEd Advocacy Learning Materials held last April 21-23, 2023 at Bella Vista Resort, Nagulian, La Union.
