





RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT – SMALL VALUE PROCUREMENT TO BELLA VISTA RESORT

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of **Board and Lodging for the Capacity Building Cum Strategic Goal Setting for Maximized Service Delivery** with an Approved Budget for the Contract (ABC) of **Eighty One Thousand Four Hundred Pesos Only (₱81,400.00)** (Annex A);

WHEREAS on November 7, 2022, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:

WHEREAS the proposal of **BELLA VISTA RESORT** is found to be the most compliant with the PR, and its price quotation amounting to **Seventy Eight Thousand Two Hundred Seventy Five Pesos Only (₱78,275.00)** is the most economical and advantageous to the Government, thereby the same as the lowest calculated responsive bid;

WHEREAS Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative.

RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the procurement of Board and Lodging during the conduct of “Capacity Building Cum Strategic Goal Setting for Maximized Service Delivery with an Approved Budget for the Contract (ABC) of *Eighty One Thousand Four Hundred Pesos only (₱81,400.00)* (Annex A);

WHEREAS the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;

WHEREAS pursuant to Section 48 of the afore-cited Rule, the Department of Education – Division of Baguio City (DO) may resort to the alternative method of procurement – *Small Value Procurement* to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex “H” of the IRR and does not fall under shopping in Section 52 of this IRR;

NOW THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to resort to the alternative method of procurement – *Small Value Procurement* for the procurement of Board and Lodging during the conduct of “Capacity Building Cum Strategic Goal Setting for Maximized Service Delivery”;
