– SMALL VALUE PROCUREMENT TO MARAND RESORT AND SPA**

**WHEREAS** the Department of Education prepared the Purchase Request (PR) for **Board and lodging for the Annual Review and Impact Assessment of ALS PPAs cum Rebuilding Reflective Leadership and Spiritual Upliftment** with an Approved Budget for the Contract (ABC procurement of) **Ninety One Thousand Pesos Only (₱91,000.00)** (Annex A);

**WHEREAS** on March 23, 2023, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/contractors signified their intent to participate by submitting their respective quotations/proposals, *to wit*:

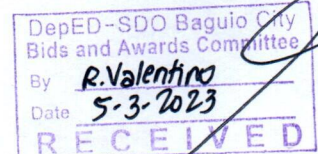

**WHEREAS** the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;




