WHEREAS the Department of Education prepared the Purchase Request (PR) for the **Procurement of Reproduction Supplies for the Series of Capability Building Activities for Self Learning Modules (SLMs)** with an Approved Budget for the Contract (ABC procurement of) **One Hundred Four Thousand Seven Hundred Twenty Seven Pesos and 95/100 only (P104,727.95)** (Annex A);

RESOLUTION NO. 153 s. 2023

RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the “**Procurement of Reproduction Supplies for the Conduct of Series of Capability Building Activities for Self Learning Modules (SLMs)**” with an Approved Budget for the Contract (ABC) of **One Hundred Four Thousand Seven Hundred Twenty Seven Pesos and 95/100 Only (₱ 104,727.95)** (Annex A);

WHEREAS the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;

WHEREAS pursuant to Section 48 of the afore-cited Rule, the Department of Education – Division of Baguio City (DO) may resort to the alternative method of procurement – **Small Value Procurement** to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex “H” of the IRR and does not fall under shopping in Section 52 of this IRR;

NOW THEREFORE, We, the Members of the Bids and Awards Committee, do hereby **RESOLVED** as it is hereby **RESOLVED**, to resort to the alternative method of procurement – **Small Value Procurement** for the procurement of reproduction supplies for the conduct of “**Capability Building Activities for SLMs**”;

RESOLVED FINALLY, to post this Resolution at the DO Website, PhilGEPS (if Php50,000.00 and above), and other conspicuous place at the premises of the DO.

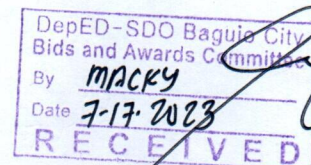
