**RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE MODE OF PROCUREMENT  
 - SMALL VALUE PROCUREMENT TO SYDBLAKES CATERING SERVICES**

**WHEREAS** the Department of Education prepared the Purchase Request (PR) for the procurement of *meals and snacks for the JCES Year-End Program Review and Evaluation 2023* with an Approved Budget for the Contract (ABC) of *Sixty Seven Thousand Two Hundred Pesos Only (Php 67,200.00)* (Annex A);

**WHEREAS** on *August 3, 2023*, the DepEd – Bids and Awards Committee (BAC) posted/published the Request for Quotation (RFQ) for the said procurement project. The following suppliers/distributors signified their intent to participate by submitting their respective quotations/proposals, to wit:

**WHEREAS** the proposal of **SYDBLAKES CATERING SERVICES** is found to be the most compliant with the PR, and its price quotation amounting to **Sixty Three Thousand Nine Hundred Thirty Six Pesos Only (Php 63,936.00)** is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated responsive bid;

**WHEREAS** Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative.


