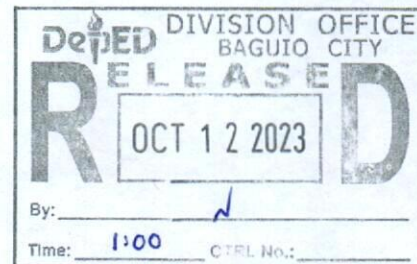

**SUBMISSION OF LEARNER GOVERNMENT GENERAL PLAN OF ACTION AND
 CONDUCT OF THE STATE OF THE LEARNER GOVERNMENT ADDRESS (SOLGA)**

1. With the Supreme Secondary Learner Government (SSLG) and Supreme Elementary Learner Government (SELG) as the foremost co-curricular student organization authorized to operate and implement pertinent programs, projects and activities in schools, and in consistent with the **OUOPS No. 2023-03 Memorandum** dated May 5, 2023 otherwise known as the **Interim Guidelines of the Learner Government Program (LGP) for School Year 2023-2024**, Article VIII, the Powers, Duties and Responsibilities of the SELG/SSLG, Section 1:1.8 *"To spearhead the crafting of the SELG/SSLG General Plan of Action (GPOA) ... xxx"*, and Article X, Duties and Functions of the Learner Government Officers, Section 1:1.11 *"conduct a State of the Learner Government Address (SOLGA) during the first and last quarter of the school year"*, this Office informs all public Elementary and Secondary schools the conduct crafting of GPOA and SOLGA on the month of October, 2023.

2. The following schedule shall be observed:



3. Submission of the approved GPOA through youthformationbaguioicity@gmail.com not later than **October 27, 2023 (Friday)**.

4. It is directed that School Heads shall monitor the crafting of the GPOA with participation of all learner clubs and organization presidents through the coordinating council.



5. Time allotment for each learning/subject area may be adjusted for the conduct of SOLGA on October 30-31, pursuant to **DepEd Order No. 021, s. 2019** entitled *Policy Guidelines on the K to 12 Basic Education Program*.
