

CONDUCT OF SIMULTANEOUS TREE PLANTING ACTIVITY IN SUPPORT TO PROJECT - "DEPED'S 236,000 TREES - A CHRISTMAS GIFT FOR THE CHILDREN"

- 1. Relative to **DepEd Memorandum No. 069 s. 2023** titled: "**DepEd's 236,000 Trees A Christmas Gift for the Children**", this office announces the conduct of a simultaneous tree-planting activity on December 6, 2023 at 8:30am to be participated by all schools, to plant a minimum of 5 seedlings which can be fruit-bearing trees, Philippine native species trees or any trees that thrive in the locality.
- 2. The objective is to provide a unique educational opportunity for students to actively participate in tree planting activities, fostering a deeper understanding of environmental issues and promoting conservation efforts. In addition to the educational benefits, planting trees will contribute to the beautification of school grounds.
- 3. Each participating school shall designate a team consisting of teachers, learners, and staff members responsible for the planning, and reporting on the tree planting activity. The team should include at least one teacher-incharge and student representatives. There should be no more than 10 teachers and not more than 20 learners who will participate in the activity. Only a maximum number of 30 individuals should join the tree planting. Classes in all public schools will be on asynchronous mode for this day.
- 4. Schools should consider the necessary resources for the activity such as treeplanting tools and materials for the tree care. School grounds will serve as the venue for the activity, however if the space is limited, the School Head should find an alternative area such as barangay parks, local government parks, or any other open space near the school that may be used for tree planting. Schools within close proximity to each other may share a venue for the tree-planting activity. In view hereof, school heads need to coordinate closely with their respective barangay officials and CENROs.

- 5. There will be a simultaneous social media broadcast through Facebook Live which will be simulcasted all throughout the tree planting activity that will be conducted by the participants using their respective school's official Facebook Accounts. The official hashtag for the post is #depedxmastrees.
- 6. Schools shall prepare a one-page post-activity report (attached hereto as Annex A) containing the details of the activity. You may access this link to submit report, right after the activity: dependence-com/treeplanting.

- 7. The School heads need to secure certification from their respective CENRO as regards the number of trees planted and the kind of trees planted. They will be responsible for ensuring the proper care of the trees planted within their premises. For trees planted outside the premises of the school, the school heads may coordinate with the barangay officials where the trees were planted so that regular monitoring of the trees' growth is done. Regular monitoring by the school officials shall be done in order to ensure the health, growth, and sustainability of the trees under the school's care.
- 8. To ensure smooth and orderly flow of this activity the Public Schools District Supervisors are task to monitor the conduct of this activity under their area of responsibility. Private schools are likewise encouraged to support this project.
