WHEREAS the BAC received a request for the "Procurement of Plaque and Materials for the Conduct of Recognition of Service Awardees and Outstanding Employees and Schools through Pammadayaw 2023" with an Approved Budget for the Contract (ABC) of One Hundred Forty Four Thousand Five Hundred Twenty Pesos Only (P 144,520.00) (Annex A);

**WHEREAS** the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

**WHEREAS** pursuant to Section 48 of the afore-cited Rule, the Department of Education – Division of Baguio City (DO) may resort to the alternative method of procurement – **Small Value Procurement** to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and does not fall under shopping in Section 52 of this IRR;

**NOW THEREFORE**, We, the Members of the Bids and Awards Committee, do hereby RESOLVED as it is hereby RESOLVED, to resort to the alternative method of procurement – **Small Value Procurement** for the procurement of plaque and material for the conduct of "Recognition of Service Awardees and Outstanding Employees and Schools through Pammadayaw 2023";
