**RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE MODE OF PROCUREMENT  
- SMALL VALUE PROCUREMENT TO BENNY TAMI-ING ENTERPRISES**

**WHEREAS** the Department of Education prepared the Purchase Request (PR) for the procurement of *siphoning/ desludging of septic tank* with an Approved Budget for the Contract (ABC) of *Sixty Thousand Pesos Only (Php 60,000.00)* (Annex A);
