





WHEREAS the Bids and Awards Committee (BAC) received a request for the procurement of **INTERNET SUBSCRIPTION EXPENSES (INTERNET CONNECTIVITY)** for the month/s of January - December 2024 with the Approved Budget for the Contract (ABC) Fifty Four Thousand Pesos only (Php 54,000.00) (Annex A);

WHEREAS the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;


WHEREAS pursuant to Section 48 of the afore-cited Rule, the Department of Education – Happy Hollow Elementary School may resort to the alternative method of Negotiated Procurement – **INTERNET SUBSCRIPTION EXPENSES (INTERNET CONNECTIVITY)** for teachers’ use – to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex “H” of the IRR and does not fall under shopping in Section 52 of this IRR;


