Promo Mechanics



- 1 Open to all registered active Pag-IBIG Fund Coordinators and Employer Representatives.
- 2 To qualify, Fund Coordinators and Employer Representatives must successfully submit a minimum of ten (10) approved Pag-IBIG MPL applications during the promo period.
- 3 Every five (5) approved Pag-IBIG MPL applications equal one (1) system-generated raffle entry (e.g. 5 applications = 1 entry; 8 applications = 1 entry; 10 applications = 2 entries and so on).

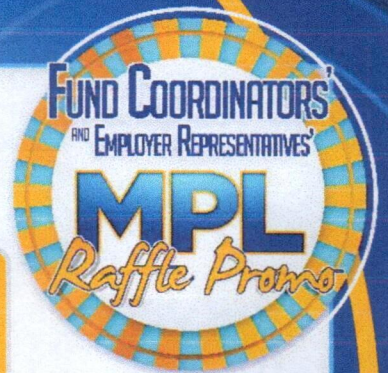

Raffle Mechanics



- 1 Draws shall be done manually by Pag-IBIG Fund Officers using a tamblo under the presence of Commission on Audit (COA) and / or Pag-IBIG Fund Internal Audit Representatives
- 2 A Fund Coordinator or Employer Representative may only win once per raffle period. If an employer name which represents Fund Coordinator or Employer Representative is drawn more than once, the higher prize will be awarded while the lower prize will be redrawn.
- 3 All winners shall be notified through telephone, e-mail or registered mail based on the winner's contact details with the Pag-IBIG Fund.
- 4 All winners shall authorize Pag-IBIG Fund to disclose and publish their names, photos, and other information, as we deem appropriate.



How to Claim Prizes



- 1 All prizes may be claimed at the concerned Pag-IBIG Fund Branch. All efforts shall be exerted in ensuring that the prizes are received by the winner. Disbursement of prizes shall conform to the regular audit and accounting procedures.
- 2 All winners must present the following upon claim:
 - o Official E-Mail, SMS or Mail notification from Pag-IBIG Fund;
 - o Pag-IBIG Loyalty Card Plus, or one (1) valid Identification Card (e.g. company ID, Philippine Passport, driver's license, or any acceptable government issued ID).
 - o Authorization letter and valid ID of the representative, if claimant is other than the winner.
- 3 Prizes not claimed after six (6) months from date of the raffle draw shall be forfeited.
