

WHEREAS the Department of Education prepared the Purchase Request (PR) for the Procurement of Transportation Service Vehicles to Ferry Food Commodities Once a Week for Forty Four (44) Weeks in Identified SBFP Recipient Schools with an Approved Budget for the Contract (ABC) of One Hundred Ten Thousand Pesos Only (P 110,000.00) (Annex A);
