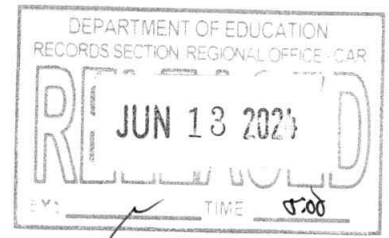

1. Relative to the upcoming pilot implementation of the **Class-In Connect Project** in DepEd – CAR, this Office through the Curriculum and Learning Management Division (CLMD) requests for the submission of list of elementary schools from the various Schools Division Offices (SDOs) who meet the following the following criteria:

- a. *Must have a stable internet connectivity in school; for target learners, must have a stable internet connectivity at home.*
- b. *Must have a high need for learning intervention among learners in Key Stage 1 in Mathematics, Science and Reading based on the results of various assessments.*
- c. *Must have learners and parents who are willing to conduct classes after classes or on Saturdays.*
- d. *Must have teachers who are willing to assist learners in the use of tablets for distance learning.*
- e. *Must have a supportive school head who can oversee the implementation of Class-In Connect in the school and at home.*
