



RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the “**Procurement of Meals and Snacks for the Contextualization of Curriculum in All Learning Areas and Grade Levels**” with an Approved Budget for the Contract (ABC) of **One Hundred Sixty Thousand Pesos Only (P 160,000.00)** (Annex A);



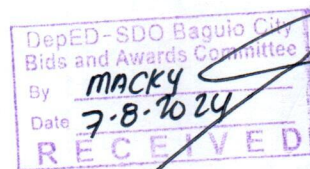
