WHEREAS the BAC received a request for the "Procurement of meals and snacks for the conduct of Orientation Workshop on the Administration of National Achievement Test (NAT G6 & RAT G6)" with an Approved Budget for the Contract (ABC) of <u>Sixty Nine Thousand Six Hundred Pesos Only (P 69,600.00)</u> (Annex A);
