




RESOLUTION NO. 371 s. 2024 RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the "Procurement of Transportation Vehicle Service for the Conduct of the Division Training of Service Orientation for Division Office Personnel (Non-Teaching) Cum Wellness Program" with an Approved Budget for the Contract (ABC) of Seventy Seven Thousand Pesos Only (P 77,000.00) (Annex A);

WHEREAS the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;

WHEREAS pursuant to Section 53.9 of the afore-cited Rule, the Department of Education – Division of Baguio City (DO) may resort to the alternative method of procurement – **Small Value Procurement** to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and does not fall under shopping in Section 52 of this IRR;

NOW THEREFORE, We, the Members of the Bids and Awards Committee, do hereby RESOLVED as it is hereby RESOLVED, to resort to the alternative method of procurement – **Small Value Procurement** of transportation vehicle service for the "Conduct of the Division Training of Service Orientation for Division Office Personnel (Non-Teaching) Cum Wellness Program";
